- II. Relationship to Knowledge Base:** GENERAL STUDIES
This is an elective course in general studies. Students throughout the University may choose to take this course for credit. It provides an opportunity for students to gain knowledge and motor skills in the area of psychomotor learning.
- III. Goals:**
This course is an introduction to the activity of volleyball.
- IV. Competencies/Objectives:**
Upon completion of this course, the student should be able to...
- Gain a basic knowledge of rules and terminology of volleyball.
 - Develop the basic skills necessary for satisfactory participation in volleyball.
 - Develop an interest in volleyball as a valuable leisure time and coeducational activity.
 - Enjoy social interaction during physical activity.
- V. Content:**
- Fundamental Skills: serve (underhand and overhand), forearm pass, set, spike, block
 - Elementary Strategy: proper positioning of players/rotation, simple offensive patterns, basic defensive play

- Court shoes and socks. (No jogging shoes)
 - Shorts, T-shirts, warm-ups or sweatshirts.

IX. Attendance Policy: Attendance is **mandatory** and is a **large portion** of your grade for this class. You will be allowed 3 free absences during the course of the semester. Thereafter, each absence will lower your grade by one letter, (Ex. 0-3 = A, 4 = B, 5 = C, 6 = D, 7+ = F). University excused absences must be made up to receive credit. It will be your responsibility to make arrangements with me to schedule the make up time. It will also be your responsibility to turn in (to me) all documentation necessary to verify your make up class(s). If you are more than 10 minutes late to class, or if you leave class more than 5 minutes early, you will be counted tardy. 3 tardies = 1 absence. IT IS YOUR RESPONSIBILITY to sign in, whether you are on time or not. If you do not sign in, you will be counted absent! If you cannot participate in class, do not come to class. **Your grade is greatly determined by participation!**

X. Pass-Fail Options: Students have the option of taking activity courses (EXSA or DNCA) under the Pass-Fail basis, rather than under the conventional grading system. Instructors must inform the students at the beginning of the semester of the option. Instructors should also inform the students that the grade of "C" is required to pass on the P-F grading system. Students electing to P-F grading system must sign the Pass-Fail form BEFORE or ON Census Date. Instructors are responsible for keeping the P-F form on file for reference when recording semester grades. A "P" will not be calculated in the GPA; however an "F" will calculate.

Drop/Add Policy: The University has taken the position that the process of adding or dropping a class is the responsibility of the student. Faculty and/or staff members should not drop students from class for any reason without the express written consent of the student. Adding or dropping a student from a class for which the student must assume financial liability without the express consent of the student places a heavy burden or responsibility on the institution and ultimately, the Registrar. We are no longer responsible for dropping students who have never attended a class, and we cannot add a student to the roll. Therefore, our department faculty should put the following statements on their class syllabi:

It is the responsibility of the student to either add or drop classes or withdraw from the university. Departments are no longer allowed to add students to rolls or drop students from rolls without written permission from the student.

Students will not be dropped for never attending. Specific deadlines set by the University can be found in the current Schedule of Classes. ***Deadlines for dropping classes may differ for Graduate Students and Undergraduate Students.*** ***It is the responsibility of the students to know these dates.***

Grade Grievance Policy: The student has one calendar year from the date a grade is assigned to initiate a grade grievance. Students should attempt to resolve the grade issue with the instructor involved. If the issue cannot be resolved with the instructor, the student must complete an "Appeal of Grade" form is available in the department office. The normal academic channels for processing this appeal are:
